KINGSROSE ANNOUNCES COMPLETION OF DRILLING AND ACQUISITION OF 51% OF THE RÅNA PROJECT

Kingsrose Mining Limited (ASX: KRM) (**Kingsrose** or the **Company**) wishes to advise that the conditions to second completion of the Transaction Implementation Agreement (as amended) announced on 18 January 2023 regarding its staged investment into the Råna Nickel-Copper-Cobalt project (**Råna Project**) have been satisfied (**Second Completion**). As at Second Completion, the Company has earnt a 51% interest in the Råna Project by incurring \$3 million of expenditure on the Råna Project and drilling more than 5,000 metres. In accordance with the Transaction Implementation Agreement, the Company has issued Metals One Plc, the nominee of Scandinavian Resource Holdings Pty Ltd with 1,000,000 fully paid ordinary shares in the Company as part consideration for the earn in.

Kingsrose has also successfully completed its recent drilling program at Råna (see ASX announcement dated 12 August 2024). A total of 706 metres was drilled over three drill holes, drill core samples have been dispatched to the analysis laboratory and will be announced in due course.

Fabian Baker, Kingsrose Managing Director, commented "We have successfully applied modern exploration techniques and interpretation to the Råna project, which has demonstrated a large and prospective project for the discovery of high-grade sulphide nickel-copper-cobalt mineralisation. We look forward to the results of recently completed drilling and rolling out our proven targeting methodology across a wider area of the project."

The Company intends to proceed to earn the third milestone interest, which equates to a 65% interest in the Råna Project, by incurring a further \$4 million of expenditure on the Råna Project prior to 24 July 2028, being the sunset date for the third milestone.
